# 2. Minutes and Matters Arising from previous meeting (19 January 2010)

**ACF:** A response to PA's letter to Ch. Supt. Nick Ephgrave (NE) about the use of S.60 with Blunt operations had been received. BM was asked to obtain a set of guidelines which NE said he had drawn up and given to officers.

BM said that he had sought and obtained an invitation for JW to attend the meeting at IPCC Office, Holborn 11.30am– 2.00 pm on Thursday, 4 March 2010, to discuss emerging findings from its Deaths in Custody study. WS also to attend.

**ACF:** The search to look for an alternative and cheaper Broadband and telephone line provider was in progress.

**ACF:** JT and BM had yet to look at the possibility of cheaper office accommodation at the Piano House in Brighton Terrace.

**ACTION:** AT said that CPCG needed to know what action police had taken following HMIC report on Lambeth custody suites, and that she would draft a letter formally asking NE for a response.

Publication of the Sean Rigg IPCC investigation: AT said that she had attended a Gold Group following publication of the IPCC report into the death of Sean Rigg. While a copy of the report had been given to the Rigg family's solicitor, AT said that it was not yet in the public domain and remained confidential. She added that the earliest date for the inquest would be sometime in 2011.

AT said that if the Rigg family chose to disclose the contents of the report CPCG would offer to hold a Special Meeting. Until that point there could be no discussion about it at CPCG meetings.

DA said that AT and SM could still continue to give support to the Rigg family without having to discuss the report with them.

PA said that if the IPCC's findings were deemed unsatisfactory it could have a similar public response to the Jean Charles de Menezes reports with concerns about the investigation being a litmus test in terms of confidence.

AT had spoken with Ch. Insp. Rob Atkin (CO19) and both had agreed that an interactive firearms demonstration would not be suitable for CPCG public meeting in February, which had explained at CPCG February meeting

AT said that a response to her letter to Caroline Pidgeon, MPA Lambeth Link Member had been received.

## 3. Administrator's Report

BM reminded the Board of LVAC's Community Advocate courses still available on 22, 23 and 25 February.

BM reported that Eaves Housing, which supported vulnerable women, was seeking CPCG's support for a bid for Home Office funding to provide an Independent Sexual Violence Advisor (ISVA) in the borough of Lambeth. AT said that she had discussed the matter of match funding with Ann Corbett (AC), Community Safety.

JW and BM would be attending the Lambeth police recruits induction day at Gipsy Hill on 19 February.

BM reminded the Board of the Safer London Foundation's final CEP session at Stockwell Community Resource Centre, 11 a.m. to 1.00 p.m. on Saturday, 6 March. DA said that for the uninitiated such events were useful.

### 4. Finance and Funding

JT produced a Finance Report laying out CPCG financial position as of 16 February.

AT and JT had completed the CPCG funding bid to MPA, which had been signed off by NE and AC.

JT said that NE wanted CPCG (which worked on a borough level in terms of people's right) to think about how it related to SNPs (which worked at neighbourhood level with regard to safety).

BM

PA said that, like CPCG, SNPs were critical friends of the police and could provide an opportunity for working more closely. He added that CPCG should find out when the funding for PCSOs was due to finish, in order that CPCG could be in a position to respond. JT referred to the Greater London Assembly (GLA) for information, which, for example, proposed an increase in the number of Special Constables. BM to check GLA website.

AT said that SNP representation needed to be recruited to the Board.

JT said that at a recent MPA committee meeting, it had been stated that the MPA was completing a consultation with CEGs about its Community Engagement Strategy, although not all CEGs, CPCG included, had heard about it. MPA would publish a document in relation to the Strategy.

WS said that he was aware that Santander bank was providing funding for community enterprises and he would look into it.

## 5. Safer Lambeth Partnership Update

AT said that SLP had produced two draft strategic documents on Prostitution and domestic violence. She said she thought that it would better if the voluntary sector wrote the strategies and SLP to provide the workers.

AT said that George Marshman (GM) had given a presentation about a review of Lambeth's CCTV, which didn't appear to be working effectively. She said that she had asked GM to give an update to CPCG.

AT asked BM to circulate SLP papers to the Board (and membership?)

PA suggested that the S&SMG draft a letter to NE with view of formally stating its concerns about the non-collection of S&S data and its ramifications in respect S&S London-wide and Pennant.

JT proposed that the S&SMG meet an hour before the police arrived at the next meeting to discuss issues to be raised.

Next S&SMG meeting would be on 24 February.
