Mental Health and Community Safety

Over the past month there have been two meetings of the Mental Health and Community Safety Working Group (MH&CS) involving the Safer Lambeth Partnership and CPCG members, Anna Tapsell and Jane Warwick. One of the outcomes so far is a commitment to form a Mental Health forum for service users and the police. Also, there have been dates set for the MH&CS to meet on a monthly basis up to the end of the year.

Recruit Market Place

On June 12, CPCG will participate in a 'Recruit Market Place' event at Gypsy Hill Police Station for Lambeth New Recruits as part of their training programme. The aim will be to provide information to new recruits about the work by Community & Partnership and work with schools, young people, Safer Neighbourhood Teams, voluntary organisations, groups and other agencies.

This will be a pilot trial which, if hopefully successful, can be used as a model for recruits in general.

HMIC and G20

Jim Toohill attended a meeting (27 May) between representatives of London Community Police Partnership (LCP2 – the umbrella organization for London CPCGs) with HM Inspectorate of Constabulary. HMIC set out the work they had done to date to garner accounts and views of events at the G20 protest (including contacts passed to them from IPCC), plans for an opinion survey and their reporting plans – there will be an interim report by the end of and a final report (which will include international comparisons of policing protest, including experience in Northern Ireland) in the autumn.

The festival has been curated by a group of young people (19-25 years old) from New Generacion and RefugeeYouth that come from different countries: Colombia, Somalia, Ethiopia, Iraq, Afghanistan, Eritrea, Zambia, D.R. Congo, Sudan, Rwanda, Palestine, Kosovo, Algeria, Angola, Guinea, Jamaica, Burundi, Bangladesh, U.S.A., France, Greece and England. Meeting weekly over three months to watch and discuss films from different angles, young people have created an amazing 3 day programme to be presented at the BFI in celebration of Refugee Week.
