Lambeth Community Safety Forum

This is a proposal for a new, borough wide community forum for crime and disorder issues. A number of CPCG members have enquired about this forum and its relationship with CPCG. This briefing is written as part of the accountability from CPCG Group Officers (JT and PA) to CPCG members. It is based primarily on two meetings, sets out our best understanding of the issues. Official minutes of meetings have not yet been produced so this account is based on notes and recall of meetings, email exchanges, discussions and so on. Some details (names, posts etc) may not be exactly accurate and representations of other people's views are made in good faith.

July Meeting

The new forum is a proposal from Rachel Heywood (Chair of Brixton Area Forum and Crime Working Group) with Harriet Smith (Director of Lambeth Crime Prevention Trust) and sponsored by Jonathan Toy (LBC Head of Community Safety). An initial meeting was called for 12 July, with representatives of 20 or so community groups invited.

In the event, 2 representatives of Brixton Area Forum attended (Rachel Heywood and Jim Toohill also a member of CPCG), together with the chair of Lambeth Leaseholders Forum (Marie Hennelly, also affiliate member of CPCG) and Paul Andell Vice-Chair of CPCG. Otherwise the attendance was:

The meeting was chaired by Rachel. Jonathan gave a presentation about the structure and operation of the Crime and Disorder Reduction Partnership and AN Analyst gave one describing the analytic capacity, especially in mapping, of the Partnership. (It would be useful to invite Jonathan and colleagues to present some of this material at a CPCG event – there are some powerful tools now available)

Key discussion of the purpose and operation of the proposed forum was:

- There was a need to provide a means for a community input to the CDRP. Rachel (as Chair of Brixton Forum) sits on both the Board and Executive of the CDRP (Lee Jasper sits on the Board). It is difficult for community members to attend these meetings because they are held in the daytime. So the new forum could be a bridge into the CDRP. The forum would meet quarterly in the evening of every other CDRP Executive meeting (the latter meets 6 weekly). (Rachel)
- Front line services were looking for a means to reach 'hard to hear' groups (Andy and Rebecca)
- The policy function was looking for a forum for sounding out borough wide policy (Jonathan and Darren) There was some debate how far 'one size fits all' across the borough (Jim).
- Does the proposed forum duplicate CPCG? There was some ribaldry around the vocal
 nature of CPCG's public meetings which, sadly, is what people who don't know CPCG's
 work get to hear about. Rachel felt that the proposed forum and CPCG were about
 different jobs Jim felt they couldn't be separated. Rachel and Harriet did not see the
 forum as a substitute for CPCG; Jonathan and Darren were non-committal.



- Jim and Paul argued that ultimately consultation has to be open and accessible. Rachel
 felt that the public meeting model could be far from accessible. Cllr Anglin felt that the
 proposed forum would have to have public events in some part.
- Discussion of Objectives and Terms of Reference was inconclusive and it was decided that Cllr Sanders, Rachel Heywood and Jim Toohill would meet separately to draft.
- It was not possible to elect a chair, given that the 'community' representation at the meeting was in the minority (it's anticipated that each of the statutory agencies' officers present will have voting rights).

Terms of Reference Meeting

This was between Cllr Darren Sanders, Rachel Heywood and Jim Toohill, on 5 August (after CPCG AGM and elections). Key points were:

- Is duplication with CPCG an issue? DS felt it was. JT felt we shouldn't get hung up on territorial issues rather on making sure that what needed to be done, got done. If there was convergence then we should deal with it in the longer term. Cllr Sanders said he would be meeting MPA officials in the subsequent week, to discuss the future of the CPCG
- RH still felt that there was a distinction between CPCG (which she felt was about police accountability) and the Forum which would be about problem solving. JT felt this to be a false, and ultimately unsustainable distinction. The community must engage in both the means and the ends.
- JT reiterated that true consultation had to be open and accessible. He suggested that though the Forum might consider itself a Working Group whilst it settled down, ultimately it would have to open itself up to all comers.
- It was agreed that the forum didn't need a chair, a couple convenors would be more appropriate, to progress chase etc. Meetings would be chaired by whosoever had greatest competence in the issue in hand. The forum wouldn't claim to 'speak for the voluntary and community sector', rather it would be a hub for debate where alliances could be made, consensus developed.
- It was agreed that the forum should not seek a role in delivery, which would be picked up
 on by constituent members singly or in alliances. DS felt that it should be a place to
 'look a little way down the road' and address issues strategically. RH felt that the Forum
 should get involved in delivery.
- It was agreed that there shouldn't be prescription on how the Forum might access the CDRP structure; basically it was felt that the Forum should have access to the Board and/or Executive using whatever reasonable means it felt appropriate.
- There was lengthy discussion of possible members and whether, for example, the was specific need for a BME representative or whether this might not be covered in some other group eg Faith Group.
- JT suggested that perhaps coordinating a borough response to the Home Office
 Prostitution consultation would be a useful initial project for the Forum. DS wondered if
 'Red Card' schemes (s4 2003 ASB Act) might be suitable he had concerns that these
 might cause frictions in much the way of Stop and Search and made reference to the
 MPA Stop and Search Scutiny. JT agreed to send DS copies of CPCG's input into the
 Scrutiny

Draft Aims for the Group, and Terms of Reference, emerging from this meeting, together with a list of suggested invitees, have been circulated to some of those who attended the 12 July meeting and subjected to email debate. The draft will be put to the next meeting of the proposed Forum, to be held in on October 4th.

The Metropolitan Police Authority is pleased to welcome John Roberts as a new independent member of the Authority. John was appointed at the start of the MPA's second term and will serve as the link member for Lambeth.

Commenting on his appointment John said:

"I am delighted to take up my appointment as an independent member of the Metropolitan Police Authority.

"One of my primary motivations for applying was to be part of making London safer for everyone.

"I am particularly concerned with how the Metropolitan Police Service (MPS) deal with issues of diversity in policing. As deputy chair of the Equal Opportunities and Diversity Board I will ensure that Londoners get a fair and consistently high level of policing. I will bring to the MPA my experience of working with many communities and hope that my skills will enable me to guide the MPS to ensure their policies address greater fairness for all.

"October sees the rollout across London of Recommendation 61 of the Stephen Lawrence Inquiry Report, and I chair the implementation group. Recommendation 61 states that when an officer stops a person, he must give them a record of that stop. Previously only people who were stopped and searched received a written record. This could have a significant impact on improving community trust and confidence and is a major step towards making the police more accountable to the public.
